Prize Money, Awards, Details and Distribution

- Prize money for Great American/USDF Regional Championships will be paid directly by the USDF office to the recorded horse owner within thirty (30) days of the last day of each championship.
- Champions in each region and division will receive \$437 in prize money, an embroidered vest provided by SmartPak, official supplement feeding system of USDF, and an embroidered nylon stall guard.
- Reserve champions in each region and division will receive \$291 in prize money, along with a saddle pad provided by the Great American Insurance Group, title sponsor of the championships.
- DSM (Dressage Seat medal) Semi-Final Awards: USDF will award ribbons to the top eight riders, and an engraved silver tray to the Champion and Reserve Champion. The Champion and Reserve Champion will also be invited to participate in the 2023 USEF Dressage Seat Medal Finals.
- USDF Adult Amateur Equitation Regional Final class: Neck Sashes are awarded through eighth place, Champions will receive a \$100 gift certificate from Big Dees Tack and Vet Supply and an engraved silver bowl, Reserve Champions a \$75 gift certificate and an engraved silver bowl, third place finishers a \$50 gift certificate and fourth place will receive a \$25 gift certificate.

Rainier Northwest Championship

Award Ceremony Schedule

A tentative schedule for the Rainier Northwest Championship Awards Ceremonies will be printed in the "Show Program" and the official schedule will be posted in the Show Secretary's Office by noon on the day prior to the beginning of the competition.

Awards & Details

- Champion and Reserve Champion will receive awards.
- Ribbons 1st through 8th place.

Open Show (Non-GAIG/USDF Championship)

Awards & Details

- First place winner in each Open class will receive an award.
- Ribbons 1st through 5th place, pinned by rider division of entries warrant.
- Test(s) and ribbon(s) can be picked up at the awards office by the exhibitor or designated adult with legible signature required.
- High point awards for the Open show will be awarded to the highest score for an Open, Adult Amateur and Junior/Young Rider.

COMPETITION RULES (GENERAL)

CLASSES

- "Q" Denotes Qualifying Class for 2023 GAIG/USDF Regional Championships.
- In test of choice classes, you must ride the highest test of the level if wanting a Qualifying ride.
- \$15 qualifying fee must be paid before the beginning of the class and is non-refundable.
- Open classes may be split if entries warrant. Will be Pinned by Division. There is no guarantee that an open class will be scheduled before the championship classes of that day.
- Open classes are filled in postmarked order.
- To accommodate all eligible championship rides, Open classes may be cancelled.
- This schedule is tentative. Championship classes may be scheduled, if necessary, on days different to those indicated above.
- Whips may NOT be carried in any Championship class including the Rainier Northwest Championship classes.
- All championship classes must be ridden from memory (no caller) including the Rainier Northwest Championship classes.

Musical Freestyles

- Only CDs are allowed and must be given to the show office the day before the class.
- Please LABEL the CD with exhibitor name and number, horse name and class number/level.
- Sound checks times will be posted at the show office on day prior to your ride time.
- **Sound checks are mandatory.**
- Competitors are responsible for picking up their music before the end of the show. Unclaimed CD's will not be returned or mailed.

Foreign Competitors

- Show management strongly advises Foreign Competitors to review GR 828.4.A in the USEF rulebook.
- Foreign Competitors who desire to compete in non-breed restricted, National Competitions in the FEI recognized disciplines in the US must have proof, in English, of membership in good standing from their National Federation or must be members in good standing of the United States Equestrian Federation.
- Competition management must request proof, in English, of current membership in good standing from their respective National Federation, or proof of current USEF membership. USEF Article GR828.4.A.

Classes

- If entering Adult Amateur classes, USEF card must declare amateur status.
- Specify test in Test of Choice (TOC) classes. If the test number and/or FEI description is not indicated on the entry, the test assigned will be the highest test of the level. A horse may enter each Test of Choice class only once.
- Every class offered herein which is covered by the rules and specifications for the current federation rulebook will be conducted and judged in accordance therewith.
- Management reserves the right to cancel, combine or reorder classes, add or substitute judges or make any other changes required.

Helmets

From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds including non-competing riders, riders on non-competing horses, and those competing in all classes and tests, including Para-Equestrian tests must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted.

FEI Pony / Pony Measurement

If ponies are entered in FEI Pony Test(s) classes and in need of a USEF measurement card, an appointment for measuring MUST be made with show management a minimum of one week prior to the show. Owners must notify show management of any ponies needing measurement, so a time can be arranged for this service. Pony Owners will pay the show for the measurement fee.

Veterinary Health Requirements

USEF Vaccination Rule (GR845). Competition Management reserves the right to review vaccination documentation. Non-compliant entries may be quarantined or denied permission to unload and will not be allowed to compete nor to mingle with other horses. No refunds will be given if right to compete is denied because the Vaccination Record is missing or incomplete. Whether the horse is vaccinated by a veterinarian or by an owner or agent, or is exempt for medical or age reasons, documentation is required; see GR845 for details. Download report form from <https://www.usef.org/documents/membership/EquineVaccinationRecord.pdf> and bring completed, signed document(s) to the competition with the horse. Because of recent EHV outbreaks the Vaccination Record for all horses will be mandatory and must be attached to all entries.

Other Terms & Requirements

- USEF rules require that competitors must request permission of the show secretary when removing their horse from the show facility prior to the end of the show. (USEF GR805.1.)
- No horse may compete in more than two successive levels at any one recognized show.
- Only one rider per horse in any one class.
- Lateness will result in elimination.
- All horses on grounds must wear a bridle number while out of stall.

Entry Rules, Policies & Terms

- No fax, email or phone entries accepted.
- All fees are to be remitted in US funds only (USD).
- Include all required, current, legible horse/rider/owner/trainer/coach documentation with entry.
- All entries must be signed. Mandatory: Owner, Rider, Trainer. Coach only if applicable
- Minors MUST have their parent or legal guardian signatures, as well as their own signature.
- Any entry received without all required information, documentation, required signatures, will incur additional fees and will be subject to the non-refundable Document Search Fee of \$20.00 per entry.
- Signature Fee of \$25.00 per entry will be assessed for any entry that is submitted without required signatures attached in original submission.
- Entries will not be accepted without full payment of fees. Credit cards may be accepted. Entries using a credit card shall have a convenience fee of 2.5 percent. Convenience fee shall only be charged once for the show entry. Receipt for convenience fee to be provided when charged.
- Electronic Entries with unpaid fees will be considered the same as a returned or NSF check.
- Entries must be submitted to Equestrian Entries, or US Postmarked by the closing date. Mailed entries must be received by the date on the prize list header.
- Late entries for GAIG/USDF Championship accepted on a space-available basis.
- Late entries for Open Classes accepted on a space available basis.

- Each entry change requested in writing, and granted by show secretary, after closing date is subject to \$15.00 fee per change.
- Confirmation of entry will be emailed to the email addresses legibly listed on the entry blank.
- Entry discrepancies must be rectified within 24 hours of emailed confirmation being sent.
- Management reserves the right to limit the number of horses a rider may enter in the same open class(es).
- Management reserves the right to cancel any classes due to hazardous weather, Acts of God, accident or emergency.
- Management reserves the right to refuse or require withdrawal of an entry for cause deemed sufficient by show management.

Post Entries at Show

Will be taken as scheduling permits, \$15.00 change fee (must request by noon the day prior).

No Show

All "NO SHOWS" that have not checked in with the show office prior to their first ride and picked up their exhibitor number will be considered as a scratch for the rest of the show and time slots may be filled. There are no refunds for scratched entries or classes. Also, scratches by competitors on the show grounds are official ONLY when made to the Show Secretary. Scratches made to warm-up or ring stewards are not official and may be considered NO SHOWS. If the competitor cannot come to the show office to scratch in person, they may send a representative.

Cancellation & Refund Policy

- Only the fees payable to Donida Farm will be considered for refund by Donida Farm.
- Cancellation of entries shall be by dated, written notification to the Show Secretary by mail or email prior to or on the closing date (entire entry refunded minus the office).
- Cancellations prior to the closing date and received by noon on August 22, 2022, will be refunded in full, less office fee and document look up fee if applicable.
- Cancellations after closing date and received by noon September 5, 2022 will be reimbursed 50% of fees less office fee and document verification fee, if applied. In order to receive the refund, a written and dated veterinarian or doctor's certificate must be received by the Show Secretary by noon September 5, 2022.
- No refunds for any reason, including inclement weather or other acts of God, after noon on September 5, 2022.
- Refund checks will be mailed to the OWNER after the final day of the show, regardless of the original person that remitted payment on account.
- Qualifying fees are non-refundable and will be forwarded to USDF.
- Refund checks expire 60 days after writing, e.g. must be cashed no later than November 30, 2022.
- Checks not cashed by that date are null and void, and all funds on those checks revert to Donida Farm.
- The competitor is responsible for reporting/requesting cancellation to Donida Farm.

SAFE SPORT STATEMENT:

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

FACILITY INFORMATION

Arenas & Footing

All tests, including all musical freestyles, will be ridden in a 20M X 60M arena. One 20M X 60M m permanent dressage arena with Premier Pro-Tech Footing, three outdoor arenas 20M X 60M with "all-weather" sand/rubber footing. Four 83' X 225' outdoor "all-weather" sand/rubber arenas. One 100' X 200' indoor arena with Premier Pro-Tech footing. 66' X 165' indoor arena with sand/rubber/Nike footing. The indoor arena is available during show hours. Large outdoor arena space available for warm-up. Lungeing arena 225' X 200' sand footing.

Children

Children must be supervised at all times.

DOGS

Dogs are not permitted on the competition grounds unless the \$50.00 Dog Permit has been paid at the show office. **All dogs must be kept away from the Competition Arenas!!!** USEF rule GR1301.6: "Dogs are not permitted to be loose on competition grounds and must be on a leash or otherwise contained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule may be subject to penalty under Chapters 6 and 7, as well as issuance of warning cards."

Unfortunately due to the past circumstance, we are strictly enforcing this:

IF there is no way to keep the dog at home or boarded out, you must register the Dog with the Donida Show office or online on your entry.

Know the rules, and abide by them.

*Dog owners must park on the race track or infield if available. The dog must be kept in the camper/RV or crated (not tied) outside the camper.

*There will be absolutely no uncrated, loose, leash walking, dogs other than in the infield.

*Dogs are not allowed anywhere except the infield on a leash.

*Any dogs with continuous barking through the day or evening will be asked to leave. If you think this is your dogdon't bring it.

* A car is NOT an RV or camper. Any dog left in a hot car for ANY length of time will be alerted to Animal control.

*Dog owners must pick up the poop.

*Dog owners must register their dog on the entry or in the office with \$50 fee. This fee is a fraction of the cost for leaving your dog at a dog boarding center. (it's your choice)

*Donida sponsors Old Dog Haven.

*Anyone breaking these rules will be asked to leave immediately with no refunds.

To clarify.....

*Anyone who steps their dog outside the race track is asked to leave.

*A leash is similar to a lead line it attaches from the dog to the owners hand.

*A crate has four walls a roof and a floor with a latch on the door.

* Unnecessary barking means it's disturbing your companions around you, or I hear it.

* Having to register your dog in the office means, knowing the rules, supporting Old Dog Haven and you are absolutely clear of the rules.

These rules are in force for a reason. Sometimes one or two people ruin it for the rest.

I love my dog, I take her everywhere I go. But I am a respectful dog owner. Please be the same. Most important please respect the reason why you're at Donida and the purpose of it.

Donida staff, or competitors should not hear, nor see "any dogs". Thank you all for taking the time to read and understand this.

Food

Food/drink concessions will be available on show grounds with services by Jeri's Cafe.

Parking

Vehicle parking is on the race track and infield.

Stabling

Portable stalls with full doors, and a LIMITED number of box stalls with full doors, are available. **All stalls will be stripped and one bale of shavings will be supplied per horse stall. Additional shaving bales can be pre-purchased with your entry for \$12.00 per bale. During the show shavings may be purchased for \$15.00 per bale. Bring your own stall cleaning equipment, water buckets, and feed. **Stalls will be available after 12:00 PM on Wednesday, September 14th. Stall Cleaning Deposit of \$50.00 per entry. Please bring a separate check for the deposit to the show office at check in. Stalls need to be stripped before leaving the show grounds. All stalls will be inspected on Monday after the show. After inspection all stripped stalls will have their deposit checks destroyed. All un-stripped stalls will have their deposit checks deposited.** Entries must be received before stabling will be reserved. All stabling will be on a first come, first serve basis. Tack rooms are available for the entire weekend at \$220.00. There will be a \$25.00 charge for nails left in stalls. Be prepared to check in at entrance "welcome barn" to verify camping, stall and doggie registration. NO OUTSIDE BEDDING, otherwise a \$30 manure removal fee is applied to competitor.**

Stalls may not be resold or sublet by exhibitors. Indicate stabling preference and stabling group on entry. Early arrivals and late departures must be prearranged directly through Donida Farm.

Manure Disposal

Please **pick** (not strip) your stalls upon departing to keep our costs down for future events. Manure Wagons are provided at the end of each barn for your convenience. Donida wheelbarrows and forks have a way of disappearing, please plan accordingly. Pick up your garbage and place it in a garbage can or in a bag next to manure wagons. **Leave it cleaner than you found it! "Take nothing but pictures. Leave nothing but hoof prints."**

Directions

From I-5, merge onto WA-18 toward Auburn. Take WA-164 E exit toward Enumclaw/Muckleshoot Reservation. Turn left onto Auburn Way S/WA-164. Follow WA-164 for 5.7 miles. Left onto SE 380th Place at "Cooper's Corner". At the end of the road, left onto 160th Place SE. Sharp right onto SE 376th Street. 16600 SE 376th Street is on your left. Look for the small Donida Farm sign. See map below.

Scheduling & Ride Times

Ride times will be e-mailed at least one week prior to the show. Schedules and results will also be made available for download and viewing at the competition website, <http://donidafarm.com> and on the Foxvillage web site www.foxvillage.com.

Donida Farm Equestrian Center General Rules

Be prepared to Check-in at the "Welcome Barn" to verify camping, stall assignment, and doggie registration. You will have your temperature taken and required to sign the County and USEF Waivers. The Welcome Barn is located just before the turn into the facility.

Main barn/arena area for "loading and unloading" only.

Park horse trailers in designated trailer parking areas only.

NO SPECTATORS ARE ALLOWED ON THE GROUNDS.

Keep fire lanes open at all times.

Camp ground use includes fire pit and showers. Please extinguish fires before retiring.

No horses allowed onto facility without being stalled. NO Haul-ins.

Campers, live-in trailers, tents must obtain a "Pass" and be visible. Charges apply.

Donida prefers that you leave your dog AT HOME! IF YOU MUST BRING YOUR DOG.... Remember this is a private facility. Dogs allowed upon registration with Donida Farm. Forms for registering your dog can be found at the Welcome Barn and in the Show office during "check-in. All fee collection (registration or fine) is between the dog owner and Donida Farm. Collars and Do-do baggies available with registration. Pay the Doggie fee of \$50.00 (% of proceeds go to Animal care groups). Dogs allowed only when tied or kenneled at campsite, trailer, tied or kenneled at stalls. No off-leash thru-out grounds. Designated Doggie "do-do" area for doggies own deposit, which must be picked up by leash handler. NO exceptions. A \$50.00 fine and removal of competitor from show grounds with no refunds...

Campgrounds must be free from horses. Please lunge in designated areas only. Not arenas.

Use manure wagons to dispose of stall manure only.

In-barn wash-racks for boarder residents only. Public rack outside barns 'C', 'D', and 'E'.

Pick-up garbage and place in or next to dumpster.

Horses may move-in after 10:00 AM the day prior to event. Stalls will not be ready before then.

No stall construction changes allowed. Any damage to stalls will incur a damage fee.

No nails in stall. Tack stalls will be charged \$25.00 for nails. **RIDERS WILL BE CHARGED DAMAGE FEES.**

No riding on race-track unless permission is granted from Donida Farm. Walk, trot and collected canter.

Bagged shavings available @ \$12.00 per bag. Pre-order on entry or order at show office.

Competitors will be charged directly for any damage done to the facility.

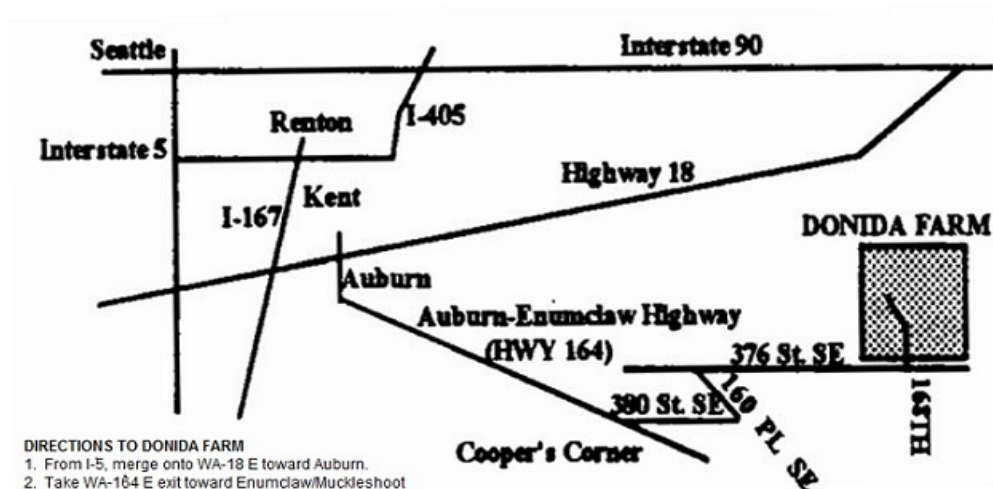

Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8th Place and gift certificates awarded to top three riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.
- or
- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

ATTENTION COMPETITORS

Each competitor is responsible for supplying management with correct association numbers (USDF, USEF) for horse, owner, rider and trainer, before the day(s) of the competition. The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

2023 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2023 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).
A horse is not required to have breed registry papers.

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual or Life Recorded Farm/Business). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form and fax or mail it to the USDF office.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

Great American Insurance Group/USDF Regional Championships Required Rules for Prize List

A. MEMBERSHIP/REGISTRATION REQUIREMENTS FOR QUALIFYING AND CHAMPIONSHIPS

Rider:

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).
- A horse is not required to have breed registry papers.

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual or Life Recorded Farm/Business). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

B. QUALIFYING CLASS AND CHAMPIONSHIP ELIGIBILITY

1. Having won a USEF/USDF Regional Championships three times (in any region over their lifetime), a horse/rider combination may no longer compete in USEF/USDF Regional Championship competition at that or a lower level (Grand Prix excepted), if they received the minimum qualifying score or higher for that division and level in the championship test per USEF DR127.5.
2. A horse may not be entered in more than one USEF/USDF Regional Championship at a particular level in the same calendar year.
3. USDF will presume qualified horse/rider combinations will compete in the region in which the rider resides as determined by the address associated with the rider's membership information on file as of July 1. Riders are NOT required to be a resident of the region to compete in that region's championship. Riders, who wish to compete at Regional Championships in a region other than their region of residence, must submit a Change of Region Form. This form must be submitted with a \$25 fee prior to July 1. Change of Region Forms may be accepted from July 2 up to August 1, with a fee

of \$100; from August 2, up to the closing date of the championship region the rider is declaring for, with a fee of \$300. **No changes of region may be made after the closing date of the region in which a rider wishes to enter, for any reason.** In addition, all persons living outside of the United States, who intend to compete in a Regional Championship, must submit a Change of Region form and applicable fee to USDF to declare a region.

4. A rider may not compete in more than one Regional Championship competition in the same calendar year.
5. In the event a competitor is unable to produce copies of the USDF membership or lifetime horse registration documents required to enter a qualifying class, a USDF competition affidavit with appropriate fee may be completed and filed with the competition secretary. The affidavit and appropriate fee must be submitted to USDF by the competition secretary. Copies of the required memberships and registrations MUST be included with the championship entry. Affidavits will not be accepted for USEF or USDF membership or horse recording verification purposes for entry in championship classes.
6. Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

E. CHAMPIONSHIP RULES

1. All Regional Championship competitions are considered Level 4. Please refer to USEF Dressage Level Requirements for specifics.
2. Each entry must designate the division being entered (open, adult amateur or junior/young rider) and must meet minimum percentage requirements for the championship division entered.
3. Cross entering open and junior/young rider divisions or open and adult amateur divisions for a horse/rider combination is permitted at adjacent levels. It is not permitted at the same level. Exception: freestyle or equivalent FEI Junior or FEI Young Rider levels.
4. If a rider intends to enter a Regional Championship as an adult amateur, the rider must be an adult by the current USEF definition (DR 119.3) and a current amateur by the USEF definition. (USEF GR1306, 1307)
5. If a rider intends to enter a championship as a junior/young rider, the rider must be a junior/young rider by the current USEF definition and her/his birth date must be on file with USDF by July 1 of the championship year.
6. Photocopies of USDF/USEF membership cards and horse recording and registration certificates must accompany

- championship entry (USDF PM for rider, USDF PM or BM for owner, etc.).
7. Under penalty of elimination, whips may not be carried in championship tests (Exception: Competitors riding sidesaddle may carry a whip no longer than 47.2 inches (120 cm), including lash, in USEF/USDF Championships.) An adjustable-length whip may not be carried by a mounted rider.
 8. Under penalty of elimination, all championship tests must be ridden from memory. (USEF DR122.1)
 9. The gate at "A" must be closed for every USEF/USDF championship ride. (USEF DR126.1.f.5)
 10. Under penalty of disqualification from all championship classes for the horse/rider combination, within 24 hours prior and at no time during a USEF/USDF Regional Championship competition may any horse entered in that Championship competition be ridden by anyone other than the rider entered in the Championship competition on that horse (exception: grooms riding on loose rein). Further, any horse entered in a championship competition, even entered at two levels, must be ridden by the same rider throughout competition. (USEF DR127.6) (NOTE: This applies throughout the entire competition, even after a horse has completed its championship classes.)
 11. In the event of a tie (equality of total points) for champion and/or reserve champion in USEF/USDF championship classes, the collective marks will determine first, second, and/or third or all three places; (i.e. when a tie for first place is broken by collective marks, tied competitors will receive first and second places, etc.). If collective marks are equal, the tie will remain unbroken (i.e. two first places will be awarded next third place, etc.). For ties in freestyle classes refer to USEF DR129.5 which states the highest score shall be declared the winner of the class. In the case of a tie, the higher artistic score shall determine the winner. Ties (equality of total points) after second place will be broken by collective marks. Ties (equality of total points and collective marks or artistic scores) occurring in third through eighth places will remain unbroken. In the case of a tie (equality of total points and collective marks or artistic scores) for champion, prize money designated for champion and reserve champion will be combined and divided equally between the two competitors.
 12. Hors de Concours entries are not permitted in USEF/USDF championship classes. (USEF DR119.5)
 13. In a USEF/USDF championship class, the horse/rider combination must obtain the necessary minimum percentage score to be named champion or reserve champion. (USEF DR123.6) If the highest placed horse/rider combination receives less than the minimum percentage, no championship awards or prize money will be issued, however an awards ceremony will be held for the entire class. In lieu of a champion and/or reserve neck sash, a first and/or second place ribbon will be awarded.
 14. In USEF/USDF championship classes, a steward must be appointed to check the saddlery, bits and spurs, on both sides of each horse immediately after it has completed its test and has left the arena. Any discrepancy to the saddlery rules will result in immediate elimination. (USEF DR126.1.i.6)
 15. A Registered (R) Dressage Technical Delegate (TD), who is a current Participating Member of USDF, is required to officiate at USEF/USDF championships. TDs for competitions offering qualifying and/or championship classes must investigate incidents of non-compliance and report violations to USEF. "R" Dressage TDs hired to officiate Regional Championship classes must be selected from outside the region. This applies only to the primary competition TD, who is the person responsible for filing the TD report for the competition with USEF. (See section H.3. c, and USEF GR1018.3 and DR127.3)
 16. Entries in USEF/USDF dressage championship classes are limited to competitors who have met the qualifications, membership, horse recording and registration requirements, and deadlines outlined in USEF DR127 and published by USDF. Competitors who are properly qualified, whose completed entries are received by the closing date for a particular Regional Championship, and who have complied with all championship rules may not be denied entry into the Regional Championship classes for which they have qualified. Only one class per division and/or level may be held to determine USEF/USDF regional champions. (USEF DR127.7)
 17. USEF/USDF championships classes may not be split. (USEF DR126.1a.4)
 18. Championship classes for juniors and young riders must only be held on Friday, Saturday, and/or Sunday. Dressage Seat Medal Semi-Finals classes must be held on Saturday or Sunday. Juniors and young riders' entries (horse/rider combinations) are limited to entry in only two championship classes, excluding freestyle.
 19. Except for freestyles, the FEI Junior Team Test, and FEI Young Rider Team test, championship classes at consecutive levels, for the same division, may not be held on the same day.
 20. Ribbons and prizes cannot be distributed prior to the arrival at the awards ceremony.
 21. All horses competing in Regional Championships classes must be stabled on the competition grounds and must remain on the grounds for the duration of their participation in the event, from the time of arrival until the horse has finished competing in all classes. If the horse has been found to have left the grounds, and returned, it would be eliminated from championship classes, but not in non-championship classes. (USEF DR127.8)
 22. For USEF/USDF freestyle championship classes, the competitor must provide the show with two CDs that contain their freestyle music, with only one freestyle music per CD that will play on a CD player (i.e. no rewritable CDs). Music should be in .WAV or MP3 format.
 23. The test ridden for national level USEF/USDF championship classes will be the highest test of the level.



2022 RAINIER NORTHWEST JR/YR, AA, & OPEN DRESSAGE CHAMPIONSHIPS

Riders from the US Northwest and Canada are invited to participate in the Rainier Northwest Dressage Championships. The goal of the championships is to create a supportive environment that showcases dressage horses and riders from the area and acknowledges their achievements. The show will be held Thursday & Friday of the GAIG/Region 6 Championships. This show is a qualifying show for the 2023 USDF Region 6 Championships.

To Qualify

To qualify for the Rainier NWDC each horse/rider combination must earn a total of two qualifying scores using any test of the level at two different USEF/USDF recognized competitions in Region 6, from two different judges. Minimum qualifying scores are listed below. **USEF tests must be used for Training through Fourth level.** All FEI test scores are eligible. **The championship rides will consist of 2 tests. All USEF classes will ride the 2nd & 3rd tests of the level (i.e., Training 2 & Training 3). The 2nd highest test will be ridden on Thursday and the highest test on Friday. All FEI and Musical Freestyle tests will be double judged.** Photocopies of the face pages of qualifying tests or USDF score check print out must be included with the entry form. No qualifying fee per class is required at the time of qualifying.

Freestyle Qualifying Scores/Classes

Minimum qualifying scores for all Freestyle levels is 60%. Rider must earn two scores at the level at which they wish to qualify, from two different judges, at two different recognized competitions within Region 6, with in current qualifying year. Freestyle Championship classes may be offered at First Level through Grand Prix.

Horse/Rider Qualification Requirements

- Rider, trainer, coach and owner need not be a US Citizen.
- Rider, trainer, and owner must be members of USEF, Equine Canada, or pay the Show Pass fee.
- EC membership qualifies Canadian competitors. Canadians should apply to USEF (no Fee) FOR AMATEUR STATUS to ride in AA classes. EC members must be USDF members or pay USDF non-member.
- All riders, trainers or owners must be at least Group Members of USDF or pay the non-member fee.
 - Qualifying is based on each horse/rider combination.
- Only one rider per horse, but riders may qualify as many horses as they wish.
- Qualifying scores may be obtained from recognized competitions held in the same Qualifying Season as the Great America/USDF.

2022 RAINIER NORTHWEST DRESSAGE CHAMPIONSHIPS -- RULES

- The gate will not be closed for Northwest Dressage Championship classes or Open classes.
- At no time during a RAINIER NWDC Championship competition, from time of entry on the show grounds, may any horse entered in that championship competition be ridden by anyone other than the rider entered in the championship competition on that horse (exception: grooms riding on loose rein).
- Any horse entered in a championship competition, even entered at two levels, must be ridden by the same rider throughout the entire competition. This applies even after a horse has completed its championship classes.
- Hors de Concours entries are not permitted in RAINIER NWDC championship classes
- Cross-entering open/adult amateur divisions is not permitted at the same or at adjacent levels except at a level that does not offer an adult amateur division.
- All championship tests must be ridden from memory.
- Champions for each level/division will be determined by the average of 2 scores.
- Whips may NOT be carried in NWD Championship classes
- In a RAINIER NWD championship class, the horse/rider combination must obtain the necessary minimum percentage score to be named champion or reserve champion.
- If the highest placed horse/rider combination receives less than the minimum percentage, there will be no Champion or Reserve Champion issued. However, an awards ceremony will be held and a first and/or second place ribbon will be awarded.
- All RAINIER NWDC championships classes will be split by division
- RAINIER NWDC Championship classes at consecutive levels may be held on the same day. Horses must have a minimum of a USDF Horse Identification number (HID) Horses must have a minimum of a USDF Horse Identification number (HID) Rider/owner need not be USDF, USEF or EC members. Show Pass and Non-member fees will apply.
- Riders must have proof of amateur status as per USEF GR 1307 or compete in the open division.
- A rider may qualify as many horses as they wish. • The rules for RNW awards ceremonies shall be those of GAIG/USDF Regional Championships. For questions, email go410s@aol.com

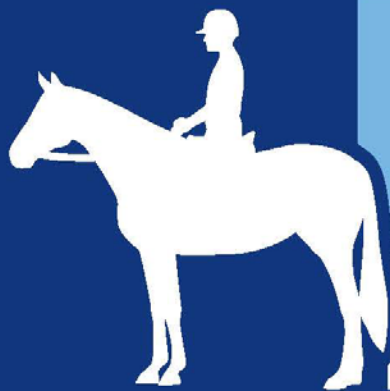

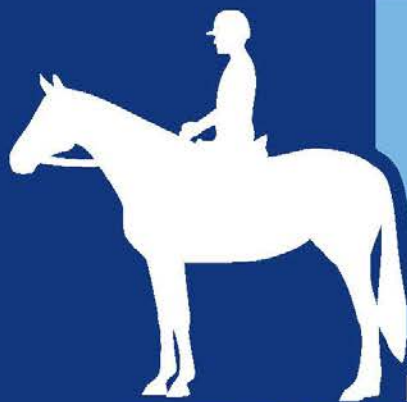

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

USEF MOTORIZED VEHICLE STATEMENT

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

US Dressage Finals Eligibility

The US Dressage Finals is an Invitational competition using the USEF/USDF Regional Championship program to qualify. Qualifying takes place at each of the nine Great American/USDF Regional Dressage Championships, based on either 1) Ranking in a Regional Championship Class or 2) Wild Card Eligibility. Either must be achieved at a Regional Championship in a class and eligible division offered at the US Dressage Finals.

I. Qualification Based on Ranking in a Regional Championship Class:

Champion and Reserve Champion horse/rider combinations for each level and eligible division from each of the nine Regional Championships will be automatically invited, provided the following three requirements are met: US Citizenship; Declaration of Intent completed by the deadline; and earning an eligible ranking in a Regional Championship class.

Note: Since Freestyle classes at Regional Championships are not split by division, the top two declared Open horse/rider combinations and the top two declared Adult Amateur horse/rider combinations for each level from each of the nine Regional Championships will be automatically invited. In addition, to be eligible for the Adult Amateur division in the Freestyles at the US Dressage Finals, competitors must check the AA box on the Regional Championship entry form and must provide proof of Adult Amateur status prior to competing in their Regional Championship classes.

- 1) United States Citizenship Requirement: To compete in any US Dressage Finals class, the rider must be a US citizen.
- 2) Declaration Requirement: The horse/rider combination must declare their intention to participate by completing the Declaration of Intent form by midnight on the day prior to the first day of their Regional Championship competition (including any open class day before the start of championship classes). **There is no fee to declare, but horse/rider combinations must declare at the level(s) and eligible division(s) they intend to compete in at the US Dressage Finals. Go to www.usdressagefinals.com to declare.**
- 3) Ranking in a Regional Championship Class: Eligibility to enter US Dressage Finals classes is based on a horse/rider combination's ranking in a Regional Championship class. Champions and Reserve Champions in eligible classes will be automatically invited, as long as they have declared by the deadline. *Note: In order to be named Champion and Reserve Champion in a Regional Championship class, a horse/rider combination must have achieved a score of 57% or higher.*

In the event that the Champion and/or Reserve Champion declines the invitation, or are ineligible to compete in the US Dressage Finals, the horse/rider combination that has the next highest ranking in the class will be eligible, providing they:

1. Are a US citizen.
2. Completed the Declaration of Intent for that particular level and division by the deadline.
3. Achieved the pre-requisite score of 57% or higher.

If that combination declines, the same process will be followed down through the fifth ranked declared horse/rider combination for that Finals level and division.

No notifications will be issued beyond the fifth ranked, of declared horse/rider combination except as may be eligible through the Wild Card invitations described below.

II. Qualification Based on Wild Card Eligibility:

Rev. 3/10/2022

Horse/rider combinations who are not otherwise qualified to compete in the US Dressage Finals based on their Regional Championship ranking (see above) may be invited to participate in a Finals class by earning a Wild Card score achieved at one of the nine Regional Championships, provided the following two requirements are met: US Citizenship and earning an eligible Wild Card score in a Regional Championship class.

- 1) United States Citizenship Requirement: To compete in any US Dressage Finals class, the rider must be a US citizen.
- 2) Eligible Wild Card Score: Eligibility to enter US Dressage Finals classes is based on a Wild Card score earned in a Regional Championship class. For all levels and divisions from Training through Grand Prix, a horse/rider combination that competes in a Regional Championship class and achieves a score at or above the score listed below for that level and division may compete in the same level and division at the US Dressage Finals.

Note: Horse/rider combinations are not required to have filed a "Declaration of Intent" in order to receive a Wild Card invitation.

III. Invitations:

Invitations and notifications will be emailed to eligible/qualified horse/rider combinations immediately after each Regional Championship. There will be three categories of emails:

- 1) Invitation emails will be sent to the top two of the top five declared horse/rider combinations.
- 2) Invitation emails will be sent to combinations eligible for a Wild Card.
- 3) Notification emails will be sent to the third to fifth declared horse/rider combinations, notifying them that they are on the reserve/alternate list and reminding them to check the website for any status changes that would make them eligible for an invitation.

In the event that an invited horse/rider combination scratches, invitations may be issued up to the start of the competition.

Note: Competitors do not need to receive an actual invitation to nominate themselves for the US Dressage Finals. The entry system will have their eligibility status and they can nominate prior to receiving an email invitation.

IV. Nomination Requirement:

Nomination, including payment of the nomination fee, is required for participation in US Dressage Finals classes, whether qualifying through ranking in a Regional Championship class or by Wild Card Eligibility. The nomination deadline is midnight, 96 hours after the last championship day in the regional championship show in which the horse/rider combination competed. Each US Dressage Finals horse/rider combination is required to complete the nomination (preliminary entry) process including the horse/rider combinations on the reserve/alternate list. The Nomination fee paid will be applied to the total amount due at Closing Date.

V. Entry Requirements

Completed entries for the US Dressage Finals *must be received* by the closing date, October 17, 2022 midnight Eastern Time. Priority for all stabling requests (including stabling in Alltech Barns and for double stalls) will be based on the date of receipt of the COMPLETE online entry. Each online entry must include the following: full payment, fully signed 2022 US Dressage Finals entry form and signed USEF Waiver, current negative Coggins test and current Flu/Rhino Vaccine Record. All documents must be

uploaded when you receive your online entry confirmation from Horseshowoffice.com, that is emailed immediately to you after you enter online. The last factor in determining stabling priority will be the allotted number of Alltech stalls available per region.
